2024 Commission Structure

30% = Base Commission Rate on total sales (popcorn and nuts)

+ 1% = attend Product Sale Kick-Off

Each unit will receive additional commission for attending one of the Product Sale Kick-offs on July 11 or July 17.

+ 2% = pay half of Show & Sell invoice by October 15, 2024.

Units that pay half of their Show & Sell invoice amount by October 15, 2024 will receive an additional commission. Show & Sell invoices will be given out at the Show & Sell distribution.

+ 1% = pay entire invoice by November 27, 2024.

Units will receive their final invoices at the Take Order distribution.

34% = the maximum commission that can be earned.

For **online** sales of popcorn, the commission is 31%.

Product Notes

- ♦ All nut products are sold 12 to the case. Most popcorn products are sold 8 to the case.
- ♦ Order by the case for Show & Sell 13 products available. You may also order up to two cases of Salt & Ground Pepper Virginia Peanuts, but this item cannot be returned.
- ♦ Order by the can, bucket, tin, or box for Take Order 24 products available.
- ♦ Place popcorn and nut orders for Show & Sell and Take Order online via prpopcorn.com. Our Council Key is **528HMC**.
- ♦ Commission structure is the same for nuts and popcorn.
- ♦ Commissions and prizes are calculated based on the total product sold (popcorn + nuts).
- ♦ Payments to Council may be made in one check (popcorn + nuts).





Go Nuts for Scouting - Prizes!

For 2024, prizes for individual Scouts will be supplied by Keller Marketing. Order prizes via the link from the Pecatonica website: proportion.com or through: kellerprizeprogram.com. Our Council Code is: 528HMC. Prize levels will be based on the total quantity of product sold (popcorn + nuts). All Scouts who sell \$750 or more may choose a bonus prize in addition to their prize level prize. Each Scout who sells a \$30 or \$50 military donation will receive a special edition Hawk Mountain Council Patch - limit one per Scout. Please note that the military patches are ordered through the prize website. Scouts are able to choose which patch they want from the 2019-2023 series, please order accordingly. The center patch for the Military Set is available at the HMC Council Store for \$5.00.

\$1,000 Sellers - All Scouts who sell at least \$1,000 worth of product will be invited to a Top Seller Celebration in 2025.

\$1,500 Sellers - Scouts who sell at least \$1,500 worth of product will receive \$75 worth of tickets to use at Knoebel's Amusement Resort during the 2025 season OR a \$75 credit toward summer camp at Hawk Mountain Scout Reservation during the summer of 2025. Knoebel's tickets / summer camp vouchers will be received in March of 2025.

\$4,500 Sellers - Each Scout who sells at least \$4,500 worth of product will receive a free week of summer camp at Hawk Mountain Scout Reservation in 2025. The free week must be used for the 2025 camping season and may not be rolled over to 2026. Please note that Scouts who earn a free week of camp will not receive the incentive for \$1,500 sellers, unless they are unable to accept the free week of camp.

Incentives for Scouts selling \$1,000+ are submitted to Council on the Special Incentives Form which is due to Ann Brugger, <u>ann.brugger@scouting.org</u> by no later than November 27, 2024.



Placing Show & Sell Orders

- ♦ You may order up to 75% of the retail value of your Unit's 2022 or 2023 sale.
- ♦ If your Unit did not sell in 2022 or 2023, please call Ann Brugger at 484-651-7938, for assistance with estimating order quantities.
- ♦ Please call or email Ann Brugger if you would like to order more product than **75%** of your Unit's 2022 or 2023 total.
- ♦ Popcorn and nuts are ordered online via <u>prpopcorn.com</u>. Our Council Key is **528HMC**.
- ♦ You may also link to the order form from the HMC website: hmc-bsa.org.
- ♦ Orders are due by July 23, 2024.

Inventory Transfers

- ♦ For the 2024 Product Sale, we will continue to allow inventory transfers.
- Inventory may be exchanged between Units. Communicate a need for product or an excess of product through our Facebook page: HMC Product Sale.
- When an exchange is arranged, both parties should complete a transfer form - see next page. The form should then be emailed to Ann Brugger at ann.brugger@scouting.org with both Unit Kernels included on the cc: line.
- ♦ Upon verification of the transfer, it will be processed in the Pecatonica River system.
- ♦ Failure to follow these procedures may result in your Unit incurring charges for incorrect product.
